Introduction

Maintaining accurate and complete student records is critical for educational institutions.

Conducting regular audits helps identify and address discrepancies, ensuring the integrity of student data and supporting informed decision-making.

Importance of Accurate Student Records



1

Compliance

Adhering to regulatory and administrative requirements for student records management.

2

Data Integrity

Ensuring the accuracy, completeness, and reliability of student information.

3

Informed Decisions

Enabling data-driven decisions that support student success and institutional goals.

4

Accountability and Accreditation

Accurate student records are essential for demonstrating accountability and meeting accreditation requirements.

Identifying Discrepancies and Errors



Missing Information

Identifying incomplete or missing data, such as missing/incorrect credits or outstanding grades, incorrect years of study, finalist indicator, or requirement term

Inconsistent Data

Detecting discrepancies between records, such as academic plan totals, career number or academic history.

Compliance Issues

Ensuring records adhere to institutional policies and regulatory requirements.

Data Entry Errors

Identifying inaccuracies introduced during the data entry or record-keeping process.



Challenges at UP

- Processing errors
- Eligible students are overlooked for graduation
- Identification of students with incorrect credit registration
- Discrepancies in practices among faculty administrators



Our Objective:

To establish structured processes to aid Faculty Administrators in identifying and auditing potential graduates.

1. uphold uniformity,
2. Streamline operations, and
3. Enhance the efficiency of student record audits – spanning from 1st to final year students

Gathering and Reviewing Student Records



1

Data Collection

Run PeopleSoft queries to identify June/November Finalists

2

Record Verification

Carefully reviewing each record to ensure accuracy, completeness, and compliance and ensuring that students have enough credits to complete their degree (Credit List)

3

Documentation

Maintaining detailed records of the audit process and any discrepancies found.

Data Collection: PeopleSoft Query

- Run a query to list all registered students for all academic years– identify all possible graduates
- Change finalist indication to June/November respectively
- Run the June/November finalist query and identify and rectify any discrepancies

Discrepancies:

- Incorrect Academic Level
- Incorrect Finalist Indicator
- Incorrect Number of years
- Missing credits
- Too many credits

Calculates total accumulated credits vs overall total
